

Terms and Conditions Governing UOB Credit and Debit Cards recurring payment on Sunseap Energy Promotion (1st April 2020 - 30th June 2020) ("Terms and Conditions")

Version: 31st March 2020

1. This UOB Credit And Debit Cards Recurring Payment on Sunseap Energy Promotion (1 April – 30th June 2020) (both dates inclusive) ("**Promotion Period**") is open to all cardholders:
 - a. Of a United Overseas Bank Limited ("**UOB**") debit or credit card issued in Singapore ("**UOB Card**") with the exception of any UOB American Express Cards, JCB Cards, UnionPay Cards, Travel Account, Corporate (on corporate liability), Purchasing, Business, Multicurrency Corporate and Private Label cards; and
 - b. Whose UOB Card account(s) is/are valid, subsisting, in good standing and satisfactorily conducted as determined by UOB in its sole and absolute discretion; and
 - c. With a registered residential address in Singapore (Collectively, "**Cardmembers**").

2. The "**Sunseap – UOB Card**" Promotion shall not be used in conjunction with any other Sunseap promotions.

3. Cardmembers who sign up for any of the following Sunseap Energy plans during the Promotion Period with the relevant Promo Code and who charge their monthly Sunseap Energy electricity bill to their UOB Card on a recurring basis (each, an "**Eligible Cardmember**") will receive the following rebate (the "**Rebate**") in accordance with the table below:

The Rebate will be reflected on the third electricity bill from Sunseap Energy.</p>
24-month Sunseap Energy Plan	SUNSEAPUOB60	<p>An Eligible Cardmember will receive a S\$60 rebate in the following manner:</p> <p>(iii) a S\$30 rebate in the first Sunseap Energy electricity bill after the electricity account is successfully transferred to Sunseap Energy; and</p> <p>(iv) an additional S\$30 rebate, applicable only when a Cardmember successfully sets up a recurring payment service using a UOB Card by the due date of their first electricity bill from Sunseap Energy. The Rebate will be reflected on the third electricity bill from Sunseap Energy.</p>

- a. Each Eligible Cardmember is limited to receive only one-time Rebate for a single Sunseap Energy electricity account, notwithstanding: -
 - i) How many UOB Credit Card(s) accounts that the applicable Eligible Cardmember has;
 - ii) or That the Eligible Cardmember charges more than one Sunseap Energy electricity bill during the Promotion Period.
4. If Sunseap Energy subsequently discovers that the Eligible Cardmember terminated the Sunseap Energy electricity contract and/or recurring payment on UOB Card within 6 months or does not qualify for the Promotion, Sunseap Energy may at its discretion, forfeit or reclaim the Rebate awarded.
5. UOB and Sunseap Energy reserve the right, at its discretion, at any time, without notice or assigning any reason thereof, to replace or substitute the Rebate with any other item of equal or similar value selected by UOB and Sunseap Energy. UOB and Sunseap Energy's determination of the replaced and/or substituted item shall be final, conclusive and binding.

6. The one-time Rebate can only be used against payments for electricity charges on the Eligible Cardmember's Sunseap electricity account. The Rebate is on a first-come-first served basis, whilst stocks last and subject to availability. The Rebate is non-transferable and not exchangeable for cash, credit or kind (in full or in part) or other goods and services.
7. The Cardmember is responsible for ensuring that all Sunseap Energy electricity bills are paid until the Recurring Payment is set up and linked to the Cardmember's UOB Card account.
8. Participation in the Promotion is subject to the Terms and Conditions.
9. The terms and conditions under the prevailing UOB Cardmember Agreement or UOB Debit Cardmember Agreement (as may be applicable) (each referred to as the "UOB Singapore Standard Terms") will continue to apply and be binding on the Cardmembers. Please visit uob.com.sg for the UOB Singapore Standard Terms. In the event of any inconsistency between the Terms and Conditions and the UOB Singapore Standard Terms, the Terms and Conditions shall prevail on matters relating to the Promotion.
10. In the event of any inconsistency or discrepancies between the Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or promotional material relating to or in connection with the Promotion, the Terms and Conditions will prevail.
11. Sunseap Energy shall not be responsible for:
 - a) any failure or delay in the transmission of card transactions by Visa International/MasterCard/American Express/CUP, acquiring merchants for the foregoing, merchant establishments, postal or telecommunication authorities or any other parties which may result in a transaction made by a Cardmember being omitted during the Promotion Period;
 - i) Any late posting of the transactions and thereby affecting a Cardmember's eligibility for this Promotion;
 - ii) Any breakdown or malfunction in any computer system or equipment;
 - iii) The acts or defaults of the telecommunication authorities, any machine or communication system, any merchant, or service provider or such other third party which maybe engaged for the Promotion;
 - iv) Any industrial dispute, war, Act of God, or anything outside the control of the Bank; and
 - v) for any costs, losses, damages, claims, expenses and/or injuries of any Cardmember or any other person howsoever incurred or suffered.
12. Sunseap Energy is not an agent of UOB and vice versa. Any dispute about the quality or service standard of UOB must be resolved directly with UOB.
13. The Promotion is not valid with any other privileges or promotions unless otherwise stated.

14. By participating in this Promotion, Cardmembers consent to Sunseap Energy collecting, using and disclosing the Cardmember's personal data for the purposes of providing the Recurring Payment services. This is in addition to any other consent which the Cardmember may have provided to Sunseap Energy in respect of the collection, use and/or disclosure of the Cardmember's personal data and shall be without prejudice to and does not derogate from Sunseap Energy's rights to collect, use and/or disclose the Cardmember's personal data under the law.
15. Sunseap Energy reserves the right to at any time in its sole and absolute discretion to amend, vary, add or delete any of the Terms and Conditions for any reason and without prior notification without assuming any liability to any person and Cardmembers shall be bound by these amendments.
16. Sunseap Energy has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether the Cardmember has met all the requirements of the Promotion. Sunseap Energy's decisions shall be final, conclusive and binding on all parties concerned and no payment or compensation will be given or paid by UOB or Sunseap Energy to any person (including the Cardmember). Sunseap Energy shall not be obliged to give any reason or enter into any correspondence with any person on any matter relating to the Promotion or its decision.
17. All information is correct at the time of publishing and Sunseap Energy makes no representation or warranty whether expressed or implied and accepts no responsibility or liability for its completeness or accuracy.
18. A person who is not a party to these Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore to enforce any term herein.
19. The terms and conditions herein shall be governed by the laws of the Republic of Singapore and the Singapore courts shall have exclusive jurisdiction over all disputes arising out of or in relation to these terms and conditions
